Ib yim los yog ib tug tuab neeg ua num xyoo 2009 yuav tau muaj feem EITC. Yog has tas cov nyaj koj ua tau los yog qhov adjusted gross income (AGI) yog tsawg tshaaj:

- \$43,279 (\$48,279 muab tso sib yuav) nrug peb tug mivnyuas los yog ntau dlua;
- \$40,295 (\$45,295 muab tso sib yuav) nrug ib yim kws muaj ob tug mivnyuas;
- \$35,463 (\$40,463 muab tso sib yuav) yog muaj ib tug mivnyuas
- \$13,440 (\$18,440 muab tso sib yuav) yog tsi muaj mivnyuas

Xyoo 2009 maximum credit:

- \$5,657 rua ib yim kws muaj peb tug mivnyuas;
- \$5,028 rua ib yim kws muaj ob tug mivnyuas;
- \$3,043 rua ib yim kws muaj ib tug mivnyuas;
- \$457 rua ib yim kws tsi muaj mivnyuasth

Based on your annual earnings, you may be eligible to receive the earned income tax credit from the federal government. The earned income tax credit is a refundable income tax credit for low-income working individuals and families. The earned income tax credit has no effect on certain welfare benefits. In most cases, earned income tax credit payments will not be used to determine eligibility for Medicaid, supplemental security income, food stamps, low-income housing or most temporary assistance for needy families payments. Even if you do not owe federal taxes, you must file a tax return to receive the earned income tax credit. Be sure to fill out the earned income tax credit form in the federal income tax return booklet. For information regarding your eligibility to receive the earned income tax credit, including information on how to obtain the IRS notice 797 or form W-5, or any other necessary forms and instructions, contact the internal revenue service by calling 1-800-829-3676 or through its website at www.irs.gov.
